31 HANKELOW NEIGHBOURHOOD PLAN 2019-30

The Parish Council considered the content of the draft Hankelow Neighbourhood Plan 2019-2030 which had been prepared in readiness for Regulation 14 Consultation.

RESOLVED:

- (a) That the content of the Plan be approved in preparation for next stage consultation, subject to the following minor amendment being made:
 - 12.21 it was noted there is a small children's play area on the Lodge Farm development, although at the moment the area is not open due to ongoing site work. It was requested that the Plan be amended to include the play area.
- (b) That following the amendment detailed above, the document be submitted to Tom Evans at Cheshire East Council for approval.
- (c) In the interim, and subject to the approval being received at (b) above, a consultation timeline and implementation plan be initially developed by the Clerk and forwarded to the Chair of the Neighbourhood Planning Group, John Durrant, for further work to be undertaken in determining the relevant statutory and other consultees; planning of the work to be undertaken up to, during and following consultation and consideration of timescales.
- (d) During the consultation period all responses should be returned to the Chair.
- (e) The Parish Council agreed that a drop-event should take place during the consultation period in the Community Room and asked that the Local Plan Steering Group build this into the consultation timeline and make the appropriate organisational arrangements.
- (f) In relation to the suggested responses to the call for sites, it was agreed that it would be the Clerk's responsibility to reply and appropriate wording was determined.
