#### 6.1 CEC Local Plan

## 8 DOG-WASTE BIN – MONKS LANE

The Clerk has asked if Cheshire East Council (through ANSA) can provide such bins.

ANSA is unable to provide a bin free-of-charge; moreover, even if the Parish Council had funds to purchase a bin, ANSA could not add collection of waste onto its waste-collection round as Monks Lane is an unsuitable road for the refuse-collection vehicle as the lane is only one-vehicle wide.
