135. HANKELow VILLAGE COMMUNITY INTEREST COMPANY

Chris Walley attended the Parish Council meeting and provided information about the Community Interest Company (CIC) that had been created. The CIC was a charitable organisation designed to benefit the community and its activities and offer an opportunity for involvement, engagement and fund-raising initiatives. It was noted that the CIC was independent from The White Lion Limited which could be used to host some of the CIC activities.

136. NEIGHBOURHOOD PLAN UPDATE

The Chair of the Neighbourhood Plan reported that the Inspectors report had now been published and the date for the Referendum had been arranged for 6 May 2021. It was noted that there was an opportunity to distribute banners and leaflets associated with the Referendum and it was agreed that two banners be purchased. Councillor Jones agreed to source a preliminary price for the banners.
